From point B to point C, price rises from \$70 to \$80, and Qd decreases from 2,800 to 2,600. So: % change in quantity = $\frac{2600 - 2800}{2800} \times 100 = -7.14\%$
% change in price = $\frac{80 - 70}{70} \times 100 = 14.29\%$
Elasticity of Demand = $\frac{-7.14\%}{14.29\%} = -0.50$
